

## Assault With Intent to Have Sexual Intercourse

Victim Aged 16 Years or Older

s.61K(b) (NSW) Crimes Act

61K with intent to have sexual intercourse with another person:

(a) intentionally or recklessly inflicts actual bodily harm on that person or a third person who is present or nearby, or

(b) threatens to inflict actual bodily harm on that person or a third person who is present or nearby by means of an offensive weapon or instrument

**Maximum Penalty:** 20 years

**Commenced:** 17.3.1991
