

Dishonestly Obtain Gain or Cause Loss to Commonwealth

s.135.1 (Cth) Criminal Code

s 135.1 (1) Do anything with intention of dishonestly obtaining a gain from a Commonwealth entity.

(3) Do anything with intention of dishonestly causing a loss to a Commonwealth entity.

(5) Dishonestly cause loss, or dishonestly cause risk of loss, to a Commonwealth entity, knowing or believing that loss will occur or that there is substantial risk of loss occurring

(7) Do anything with intention of dishonestly influencing a Commonwealth public official in exercise of official's duties as a public official

Maximum Penalty: 5 years (increased to 10 years for offences committed on or after 25.8.2018)
