Good character; caring mother – good rehabilitation prospects – mental illness; extreme depression. CCA: Should have received 25% discount for early plea, not 10% granted by sentencing judge - had offered to plead guilty before being committed for trial but offer not recorded in case conference certificate; Crown had rejected plea and plea was ultimately accepted – special circumstances mental illness.
