## Homosexual Intercourse With Male Aged Between 10-18y

s.78K (NSW) Crimes Act

s 78K Male person who has homosexual intercourse with a male person of or above the age of 10 years, and under the age of 18 years

Maximum penalty:	10 years
Commenced:	8.6.1984
Repealed:	13.6.2003

## Note: the effect of recent statutory provisions relating to the application of sentencing patterns and practices:

s.25AA(1) (NSW) <u>Crimes (Sentencing Procedure) Act</u> applied to sentences imposed on or after 31.8.2018. It required a court to sentence an offender for a child sexual offence in accordance with the sentencing patterns and practices at the time of sentencing, not at the time of the offence. 'Child sexual offence' is defined as a prescribed offence where the person against whom the offence was committed was then under the age of 16 years: (5)

This provision was replaced by s.21B(1) (NSW) <u>Crimes (Sentencing Procedure) Act</u> on 18.10.2022. The requirement that a court sentences an offender in accordance with the sentencing patterns and practices at the time of sentencing applies to all offences unless the offence is not a child sexual offence and the offender establishes exceptional circumstances. 'Child sexual offence' remains defined under s.25AA(5) as an offence committed against a person who was then under the age of 16 years.
