### s.86(1) (NSW) *Crimes Act*

s 86(1) take or detain a person without their consent:

(a) with intent hold person for ransom

(a1) with the intention of committing a serious indictable offence, or (*subsection added 24.9.2012*)

(b) with intent of obtaining advantage

**Maximum penalty:** 14 years

**Commenced:** 14.12.2001
